All rough stock riders will be during Rodeo performances only, 1<sup>st</sup> Round of all Rough Stock is Thursday 6 pm and 2<sup>nd</sup> Round is Friday 5 pm. Timed event placings are based on how you qualified for state finals. All timed events will go in slack Thursday morning for 1<sup>st</sup> Round.

11<sup>th</sup> – 20<sup>th</sup> place coming into state, go on Thursday 6 pm for 2<sup>nd</sup> Round, 1<sup>st</sup> -10<sup>th</sup> place coming into state, go on Friday 5 pm for 2<sup>nd</sup> Round. Steer Wrestling will be split evenly, 6<sup>th</sup>-10<sup>th</sup> Thursday perf and 1<sup>st</sup>-5<sup>th</sup> Friday perf. Top 10 in each event after calculations of all points accumulated at state finals and preliminary season will come back for Final Round on Sat @ 12 pm. Top 4 in Final Standings qualify for Nationals, 5<sup>th</sup> -20<sup>th</sup> qualify for SSIR.

**ENTRY INFORMATION:**

For 2026 State Finals Rodeo the top twenty contestants in each event will need to enter through the online entry system. In the case that someone does not enter, contestants will have the option of rolling up and **will be notified** by the OHSRA office if they have the opportunity to roll up. All contestants must check in on **Wednesday, June 10<sup>th</sup>, from 1:30-4:30 pm. If you cannot check in by this time, then someone may check in for you, but EVERYONE MUST BE CHECKED IN BY 4:30!** Please make sure the person checking you in has all of your information (grades & school verification) and money for your entry.

Team roping points—Points earned in team roping during the preliminary season will belong to contestant (regardless of heading or heeling or change of partners). At state finals, a team may be **ANY** two-team ropers with points. Each partner's points are added together to form a team. You must have a partner to enter with, you may not draw a partner for state finals, and you must declare the header and heeler at the time of entry. The **TOP 20 TEAMS**, after their points are added together, will be entered.

**DRAW** - Contestant positions in each event are drawn for in the first go and then the order is reversed for the second go. The final go (Saturday) is for the top 10 contestants in the year end standings after the two long goes at state finals are added in. This is determined by adding 1<sup>st</sup> go points and 2<sup>nd</sup> go points to your points coming into the finals rodeo. The final go positions will run from 10<sup>th</sup> place to 1<sup>st</sup> place in all events except the barrels and poles, where positions are drawn for.

**ENTRY** - Online entries will open on Wednesday, May 13<sup>th</sup> and close Thursday May 14<sup>th</sup> @ 4:00 PM. Dry Camping will be the only option available in the infield, each contestant will be charged \$30 for the week to dry camp or to park their trailer in the infield, there are no RV spots available this year. OHSRA will be awarding all State Finals Qualifiers a sweatshirt, t-shirt, and long sleeve shirt. Size option will be on the online entry form, this apparel is ordered to the size that you specify, no trades or exchanges will be made at state finals. First Time Nationals qualifiers will receive a 1 time National qualifier coat. This coat must be ordered by you during the NHSFR sign ups on Saturday evening, **if you leave before this and don't order your coat you will not receive one.**

**GRADES:**

**YOU WILL BE REQUIRED TO TURN IN GRADES AT CHECK IN, IF YOU HAVE YOUR FINAL TRANSCRIPT OR REPORT CARD AT THIS TIME THAT IS BEST, IF YOU ARE STILL IN SCHOOL OR CANNOT GET A FINAL TRANSCRIPT OR REPORT CARD, THEN YOU MUST GET AN UPDATED PROGRESS REPORT TO BRING WITH YOU. ALL QUALIFIERS TO NATIONALS WILL BE REQUIRED TO TURN IN FINAL GRADES BEFORE COMPETING.**

**FEES:**

Fees are to be paid when you check in at state finals.

- \$40 office charge
- \$70 per event — Includes \$10 for 1<sup>st</sup> & 2<sup>nd</sup> go-around payoff, no payoff in final round.
- \$30 for dry camping—NO electricity, camping spots in the in-field of arena

## DRESS CODE:

The dress code will be in effect from **Thursday morning – start of the slack until AFTER the awards recognition Saturday**. As stated in the NHSRA rulebook—Contestants, parents, adults, helpers and assistants must wear western attire: western hat, long sleeved shirt, western boots, and western trousers at all times during a performance while in the following areas: arena, chute area, stock working area. Contestants must wear western attire in any seating area, whether competing or not. All parents helping behind the chutes or in the arena must have western attire as well. Contestants must wear numbers on their backs and the number must be visible at all times while competing in their event, when at the rodeo or rodeo grounds or any rodeo function and at the motel.

**STATE FINALS JOBS:** State Finals is produced by the state so everyone must help. If you are a member of a club, your club will be doing a job at state finals. You and or your parents are required to help your club in completing their job. Check with your club advisor to see what your job will be. If you are independent member, you will also have a job and will be notified by Bobbi of your job.

**NATIONALS:** NEW THIS YEAR! Nationals is doing online entries for Nationals through the EQE System, you must have an account created before State Finals, instructions attached in this packet. You need to be prepared to go to Nationals before state finals. At the back of this packet are the entry forms for nationals. Most of the information can be completed before the end of our state finals. For example, **both parents and you can sign in front of a notary for minor release before** you come to state finals, and is VERY IMPORTANT if both parents are not going to attend state finals. A Current Coggins Test and a brand inspection are required on all horses before traveling to Nationals or Silver State.

**If you qualify for Nationals and you decide not to go, Bobbi MUST be notified ASAP before you leave state finals rodeo.**

National entry forms are completed at the designated National sign up and meeting time, Saturday, June 13th. **THIS IS THE ONLY TIME TO ENTER FOR NATIONALS, NO EXCEPTIONS!**

### Nationals Coats ----

*You must order your National Coat at the NHSFR sign ups in order to receive a coat. If you qualify in one of the top 4 spots of your event, OHSRA will buy you a coat whether you attend Nationals or not, if you roll up in an event and would like to buy a coat the cost is \$275 and will never be refunded even if you qualify another year.*

### National High School Finals Rodeo—July 19—25, Lincoln, NE

Top 4 contestants in each event. **All contestant housing and stalls will go through Bobbi Aldrich, OHSRA Secretary. Money will be collected on June 13th. Camping \$408.59—full service only, \$245.15 Dry Camping; Stalls \$225 or stud stall \$235. Only allowed one stall per event, extra stalls are not available. Rodeo Jackpot \$150 each event and is optional, just like a sidepot. Please know the length and model of your RV. Limited RV spots available this year, contestants taking horses will have first dibs on the RV spots, seniors will have priority after that.**

## MEMBER'S RELEASE, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

In consideration of the above-named member ("Member") being allowed to enter the restricted area (as defined below) and to participate and compete in the 2026 National High School Finals Rodeo, we, the Member, and the undersigned parent(s) or legal guardian of the Member, on behalf of the Member, and for ourselves, our personal representatives, heirs, spouse, parents, siblings, and children, do hereby:

1. RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE the National High School Rodeo Association, Inc., any other rodeo association, any rodeo committee, any stock contractor, any rodeo or event sponsors and the Sandhills Global Event Center, and each of them and their officers, directors, trustees, managers, agents and employees (all of whom are collectively referred to herein as "Releasees") from any and all liability to the Member, the undersigned, and their personal representatives, assigns, heirs, parents, legal guardians, siblings, spouse and children, and from any claim or demands therefore, on account of injury to the Member, his/her death or damage to his/her property (or injury, death or damage to property of any of the undersigned), which occurs as a result of the Member's or any of the undersigned's (1) presence in the restricted area, (2) participation as a contestant, assistant, official or otherwise in any rodeo event, and/or (3) competition for money, prizes, recognition or reward, whether such death, injury or property damage is caused by the negligence or other wrongful conduct of, breach of contract or warranty by, strict liability or otherwise by, one or more of the Releasees or other contestants.
2. AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS THE RELEASEES and each of them from any loss, liability, damage, or cost (including, but not limited to, attorneys' fees and other defense costs) one or more of them may incur arising out of or related to the Member's entry into the restricted area and/or participation in any rodeo events, whether such claim is based on one or more of the Releasees' negligence, breach of contract or warranty, strict liability or other legal theory.
3. UNDERSTAND that Member's entry into the restricted area and/or participation in rodeo events contains DANGER AND RISK OF INJURY OR DEATH TO MEMBER, that conditions of the rodeo arena change from time to time and may become more hazardous, that rodeo animals are dangerous and unpredictable, and that there is INHERENT DANGER in rodeo which the Member and each of the undersigned appreciate and voluntarily assume because we choose to do so. Each of the Member and undersigned has observed events of the type that the Member seeks to participate in. We further understand that the arena surface, access ways or lack thereof, lighting or lack thereof, and weather conditions all change and pose a danger to the Member and that other contestants and participants pose a danger to the Member. WE EACH VOLUNTARILY ELECT TO ASSUME AND ACCEPT ALL RISKS inherent in rodeo.
4. This Release, Assumption of Risk and Indemnity Agreement shall apply to the 2026 National High School Finals Rodeo and to any incident, injury, accident or death involving rodeo occurring on or after the date of the Member's signing. The term "restricted area" means the area from which admission to the general public is restricted, which includes, the rodeo arena, competition area, chutes, pens, adjacent walkways and other appurtenances. The undersigned agree that in the event any portion of this document is held to be invalid, the balance shall, notwithstanding, continue in full legal force and effect to the greatest extent possible under applicable law. If a Member becomes of legal age after signing this document, he/she shall be deemed to have ratified this document by participating in the rodeo. If the Member is a minor, the parents or guardian of the Member agree that by signing below they are in addition to binding themselves, binding the Member to the maximum extent permitted by applicable law.

### Purpose of Form

Examples of information returns include, but are not limited to, the following.

- Form 1099-DIV (dividends, including those from stocks or mutual funds)
- Form 1099-MISC (various types of income, prizes, awards, or gross proceeds)

- Form 1099-K (merchant card and third party network transactions)
