

# 2025-26 OHSRA Membership Instructions

Please read this instruction sheet fully!!!

ALL MEMBERSHIP FORMS AND DOCUMENTS WILL NEED TO BE UPLOADED AND PRINTED FROM THE NHSRA MEMBERSHIP PORTAL. [nhsra.equestevent.com](https://nhsra.equestevent.com) This includes the NHSRA Forms and the Oregon Forms.

ONCE YOUR PORTAL IS CREATED AND YOU HAVE PAID YOUR NHSRA DUES:

1. Print all the forms available including all of the NHSRA and the Oregon Forms.
  - a. 2025 unsigned application – NHSRA Form
  - b. 2025 minor waiver form – NHSRA Form
  - c. Oregon High School Membership Application – Oregon Packet
  - d. Social Media Release Form – Updated - ALL MEMBERS MUST SIGN
  - e. Regional Club or Independent membership form
  - f. Home School verification form (if you are in home school program)
2. Each of these documents need to be completely filled out, signed, notarized (2024 minor waiver form)
3. Once signed and notarized, all forms need to be uploaded back onto your portal including a copy of your final 2025 grades.
4. Once all forms are uploaded and complete you will receive an email through the OHSRA QuickBooks invoicing. This will need to be paid online. You can pay with a check or credit card. Oregon dues are \$200 for club members or \$600 for independent members.
5. You will receive your back number and rulebook by mail. The back number must be worn while competing at all rodeos.

## SOCIAL MEDIA POLICY

*In accordance with **2024 – 2026 Rules, By-laws and Constitution, National High School Rodeo Association, Article II: Membership Associations - Membership, 16.** “NHSRA membership associations shall have the authority to require signature agreements to Social Media Policies for student and adult members, as a requirement of membership. The purpose of said policies is to protect the membership association and its official representatives from inaccurate, detrimental, threatening, harassing and derogatory information, as well as from creating unauthorized websites and social media accounts utilizing the association name, whether directly or indirectly.”*

As a condition of membership in OHSRA (the “Oregon High School Rodeo Association”), the undersigned understand that the Oregon High School Rodeo Association requires student and parents to agree not to post on line any comments about the National High School Rodeo Association, the Oregon High School Rodeo Association, the sponsors of, including wearing apparel or patches of sponsors and back number, and/or its official representatives that are inaccurate, detrimental, threatening, harassing, explicit and/or derogatory, as well as to agree not to create unauthorized websites and social media accounts utilizing the Oregon High School Rodeo Associations name, whether directly or indirectly. This includes pictures and videos posted that might cause embarrassment of themselves, fellow members, the associations and their sponsors. Including any videos using explicit music. Any pictures or videos found will cause disciplinary action by the OHSRA Board of Directors and proper authorities will be called if there is suspicion of a crime.

We further understand that failure to abide by this agreement by parent(s) **or** student member(s) could result in immediate revocation of all the undersigned’s student memberships in the Oregon High School Rodeo Association, including any points awarded in the current rodeo season. This revocation of membership shall not, however, preclude the Oregon High School Rodeo Association from bringing a claim against a, parent or a parent on behalf of their minor child(ren) who is a member(s), for appropriate damages caused by the actions of either the parent, adult non-parent or student. ## Home School Verification Form

Contestant Qualifications, pg 24, Rule #1

In accordance with the NHSRA rulebook pertaining to contestant qualifications, students who attend a homeschool, private school, religious school or correspondence school are eligible for membership if the school is recognized and approved by the state/province board of education or National Board of Education in the state/province the member is applying for membership. The contestant would need to show proof that the school they are attending is accredited and that they have met the grade requirements.

If the school the student is attending is not accredited by the State or National Board of Education the student shall demonstrate composite grade-level academic proficiency on any State Board or National Board of Education recognized achievement test or other mechanism as provided for in State or National Board of Education rules. A student shall be eligible if they achieve a minimum composite score or survey test score within the average or higher than average range as established by the test service utilized on any nationally-normed test.
